Building Permit Fees  
Resolution No. 01-2005

**WHEREAS**, the Town of Gardner has adopted the Wisconsin Uniform Dwelling Code and engaged the services of a building inspector for the inspection of one and two family residences;

**AND WHEREAS** it is intended that fees be charged for the inspection services to offset this expense;

**NOW, THEREFORE, BE IT THEREFORE RESOLVED** by the Town Board of the Town of Gardner that the following building permit fees are adopted and approved for inspection of one and two family dwellings in the Town of Gardner:

I. Other Service Fees:

1. Failure to obtain a permit before work on a building has been started, except in emergency cases, the total fee shall be double the fee charged.
2. Second offense, total fee shall be tripled.
3. Third offense – fees shall be quadrupled.
4. Any other occasions may, in addition, bring about citations as directed by local ordinance.
5. Re-Inspections: \$50.00
6. Street Cleaning: Actual Cost
7. Occupancy Without a Permit: \$100 per day or as directed by local ordinance.
8. Application for Renewal or Amendment of Permit: Additional fee may be assessed per inspector.
9. Factory built and sealed homes: \$120 (covers inspection of foundation, erosion control, utility service and occupancy.)

J. Inspection Fees for One-Family and Two-Family New Homes:

1,500 sq. ft. – 1,999 sq. ft.	\$560.00	\$760.00
2,000 sq. ft. – 3,000 sq. ft.	\$650.00	\$850.00
Over 3,000 sq. ft.	\$650.00 + \$.05/sq. ft.	\$850.00 + \$.05/sq. ft.

K. State Building Seal \$25.00 or state rate.
